### SUMMARY OF EXPERIENCE

---

As an Inspector for the Health and Safety Executive (HSE) in Scotland from 2005 to 2024, I have 19 years' experience in the enforcement of health and safety law.

Throughout my career, I have completed over 1500 workplace inspections/investigations and produced over 40 reports used in legal proceedings. I have extensive experience of ensuring the regulatory compliance of companies to achieve employee safety in the workplace.

My work as a HSE Inspector has given me knowledge of a wide variety of industries including agriculture, manufacturing, engineering, power generation, healthcare, food/drinks production and construction. I also have detailed knowledge of a range of Scottish industries including muirburn (the management of heather for grazing purposes), whisky distilleries, salmon processing and health boards.

I have the skills necessary to establish immediate and underlying causes of incidents and can quickly identify whether companies are meeting their statutory duties. I have also investigated over 50 fatal accidents and have provided evidence to assist the Court in 5 cases. The causal failures have been varied and include falls from height, workplace transport, machinery safety, electricity at work and provision of care in healthcare settings.

My work has included the application of the management standards on occupational stress during a five-year Scottish health boards intervention on violence and aggression in the workplace.

Investigation and identification of serious health and safety failings resulting in submission of reports to Crown Office and Procurator Fiscal Service with reports resulting in fines of up to £1.2m. Negotiation with Employment Tribunal and Senior Counsel to successfully resolve appeals which required duty holders to take action to protect their employees from risk. Delivery of evidence in Fatal Accident Inquiries and in defended case to advise court of findings of investigation.
